



**JOINT INTERNATIONAL STATEMENT OF CIVIL SOCIETY ORGANIZATIONS ON THE
SITUATION OF HUMAN RIGHTS IN THE FRAMEWORK OF THE 2024 PRESIDENTIAL
ELECTIONS IN VENEZUELA**

(Original in Spanish)

To Venezuelan citizens inside and outside of Venezuela,

To the Member States of the international community,

**To the organizations of the Human Rights System and other institutions defending
Human Rights,**

We, all members of international civil society organized in defense of Human Rights and democracy as a system of shared values, express our deep concern about the recent events of July 28, 29, and 30, 2024, in Venezuela. We know these are not isolated events but the intensification of practices that harm the fundamental rights of its citizens to the detriment of a civic solution to the country's complex humanitarian crisis.

Political and institutional violence has increased in the context of presidential campaigns and elections. The repression and criminalization of protests are categorically outrageous and a public and notorious fact that restricts the whole exercise of the civil and political rights of the Venezuelan people. These are added to the already exhaustive list of violations of fundamental rights inside and outside the country by the government led by citizen Nicolás Maduro Moros, and that has earned him the advancement of the **active investigation by the International Criminal Court for crimes against humanity to the Venezuelan State.**

The pattern of irregularities in distant municipalities and states rules out the possibility of localized events or initiatives of individuals and, on the contrary, shows systematic actions of repression to try to prevent the free exercise of the rights of Venezuelans in peace.

We have directly a conflict between the government in office, with aspirations of re-election and in control of the electoral body, the Armed Forces and other police forces exceeding the use of coercive force, and a population demanding respect for its sovereign will, which has been expressed civically in the elections, and that does not find echo in the fulfilled obligation.

The hasty announcements of a victory of the government candidate are made implausible not only by the absence of primary evidence resulting from a transparent electoral process but by the contrast with the minutes in possession of the same citizens who have been part of the tables and that have been consistent with those shown by the Unitary Platform, for the simple reason that they have been provided by the table witnesses, in their legitimate right.

The process of appointing the winner in electoral elections can only and exclusively occur with the participation of all parties involved, public scrutiny as required by law, and transparent and auditable totals. The fact that the electoral body does not make the ballots of the vote public, as per law, with municipalities disaggregating the electoral tables, calls into question the

integrity of the results announced by the provisions of the Organic Law of Electoral Processes and the framework of the country's constitution.

Street expressions are the product of anger and impotence, a demand for respect for the citizens' will expressed in the elections—a constitutionally legitimate act. There have been demonstrations in at least 20 of the 24 states of Venezuela, including the capital. **More than 1,263 people have been arrested, including children, people with disabilities and the elderly, and 24 people have been killed and at least 40 have been forcibly disappeared.**

Therefore, the more than 300 organizations from different nationalities, inside and outside of Venezuela, with the ethical support of local organizations on an international scale, urge:

The National Electoral Council will publish and deliver the vote minutes, with tables disaggregated. This process has historically been carried out immediately and transparently, with respect for the citizens' will expressed in the elections. In turn, this will respect voters and make their will effective.

To the Public Ministry, the cessation of the criminalization of peaceful protest and plural political activism, of the citizen's right to information, freedom of expression, freedom of association, and freedom of thought. Including a cease on the harassment to Diplomats and Embassies within Caracas and asylum seekers within those embassies.

To the Armed Forces, to fulfill their constitutional responsibility to ensure that the expression of the Venezuelan people is respected, through compliance with electoral laws and to protect the Venezuelan people in the exercise of peaceful protest.

We urge:

To the international community, to support the demand of the Venezuelan people for the publication of all the voting ballots as an act of transparency and impartiality while taking action before regional and international mechanisms for effective dialogue and the guarantee of compliance with the provisions of the Barbados Agreements, as well as the protection of the rights of Venezuelans within the framework of the inter-American system, although not limited to it. The democratic governments must commit to exercising their role in the international systems to provide international protection to victims.

To Human rights organizations to replicate by all available means the verified information of independent observers, civil society, NGOs, the United Nations system, and the media to circumvent censorship in the country and contribute to the right to information and due diligence. Likewise, they should attend to the victims and support the **call for pacification with the cessation of citizen repression and the return of institutionality.**

We applaud the Venezuelan people's civic, peaceful, and determined expression in exercising and defending their rights. From this network of allied organizations honoring our raison d'être, we remain at the side of citizens searching for peace, democracy, prosperity, and understanding.

Background:

During the months before the elections, a constant imbalance of forces, violation of rights, disinformation, and coercion of citizens through social benefits and subsidies in favor of the government of Nicolás Maduro and his candidacy was observed, using public funds for electoral purposes, in addition to the obstacles imposed so that Venezuelans abroad could participate, reinterpreting legal norms, inventing non-established requirements, reducing the time for the voter registration process and days of attention, disproportionate for updating the permanent electoral registry and finally, limiting the right to vote of 5.5 million Venezuelans abroad.

Censorship, persecution, imprisonment, and forced disappearances of political leaders, social leaders, human rights activists, and disgruntled citizens increased considerably in the days before the election. The threat of enactment of laws to constrict civic space and persecute political pluralism directly violates the principles and rights contained in our national Constitution, national laws, regional conventions and treaties, the observance of fundamental human rights, and the most minimal respect for citizens as the central axis of democracy. A part of the democratic opposition forces to the government-held primary consultations in which María Corina Machado was elected and was prevented from registering her candidacy, then Corina Yoris as her replacement and later, the hindering of the campaign of the candidate Edmundo González Urrutia.

Within the framework of the monitoring carried out by Coalición por Venezuela and some twenty allied organizations, in their role of social oversight of the process, deployed through the networks of non-governmental organizations and human rights defenders, in strict compliance with our statutory mandates of non-partisan political activism and impartiality, we were able to document irregularities, violations to the Organic Law of Electoral Processes, the Electoral Processes Regulation, the Electoral Table Manual and the Constitution of the Bolivarian Republic of Venezuela, as well as the points agreed in the Barbados Agreement and violations to the Economic, Social, Cultural and Environmental Rights (ESCR). Among these violations, mainly within Venezuela but also affecting consular offices, the most common were the following:

- Delays in the opening and closing of polling stations.
- Denial of access to witnesses during the counting of ballots.
- Acts of coercion, surveillance, and manipulation at the time of voting, as well as irregularities in assisted voting.
- Acts of violence with firearms, physical and verbal aggression.
- Theft and destruction of electoral material.
- Refusal to deliver tally sheets to witnesses.
- Impersonation of voters
- Opening of the electoral boxes before the installation of the polling stations.
- Power and internet cuts and wiring theft.
- Raids on houses of members of political parties opposing the government, as well as of witnesses, table members, social observers, and human rights defenders.
- Deportations and prohibitions on entry for international guests as witnesses to the electoral process and foreign individuals accompanying civil society.
- Parallel lists with voter data for coercive purposes.
- Untimely changes in the place of voting, in the case within the country to other states and consular offices, were made to voting centers in Venezuela.

The pattern of the same irregularities in equidistant municipalities and states discards the possibility of focalized facts or initiatives of individuals and, on the contrary, accounts for coordinated actions to try to prevent the free exercise of Venezuelans' civil and political rights with transparency and competitiveness in peace.

The announcements of a victory of the government candidate become implausible not only due to the absence of primary evidence on the outcome of the electoral process but also due to the contrast with the minutes in possession of the citizens, as well as the results of exit polls of different companies, at the polls. It is vital to clarify that naming the winner in electoral elections can only and exclusively occur through public, transparent, and auditable results. The fact that the voting records are not public in their entirety, with disaggregation of the polling stations by municipalities, calls into question the integrity of the announced results by the provisions of the Organic Law of Electoral Processes, based on the principles of transparency and auditability of the process, which are indispensable for its validity.

The repression and extreme use of coercive force by the police and military authorities in recent days violate the Venezuelan constitutional framework in the extreme of the right to life, physical integrity, right to protest, assembly, and freedom of expression. All direct crimes constitute a human rights violation, with international criminal responsibility. In addition, the Republic's Attorney General, Tarek William Saab, has expressly criminalized NGOs by threatening to deprive them of their freedom. Non-governmental organizations do indispensable work defending people's rights without political, racial, creed, or sex bias. Threatening deprivation of liberty for exercising our work - protected by law- implies a crime.

Faced with the causes that originated the biggest migratory crisis of the continent, the possibility of a new wave of forced displacements of imminent and massive character, the systematic violation of human rights within the country documented before various mechanisms and international observers of the matter, it is our duty and commitment to defend human rights, promote social participation and protect the freedoms of Venezuelans inside and outside the national territory in all spaces.
